Prof. Muhammad Aslam discussed Medical Journalism in the era of Social Media, Data Analysis an Artificial Intelligence. He emphasized the importance of fact checking before sharing any news on the social media. One has to be sure about the authenticity of information sources, as it lacks in depth analysis. the journal website i.e. aims, objective, offices, editor and editorial board, ownership of the journal, processing and publication charges, timely publication, adherence to ICMJE guidelines to authorship, COPE guidelines on publication ethics, timeline of publication. Each manuscript has to be reviewed by at least two experts. Journals are supposed to keep record of all such peer review reports, plagiarism check, LOU, EC/IRB approval with reference number and date of all manuscripts published for at least two years. It is a very transparent system and the objective is to facilitate rather than create hindrances. We wish to have as many standard medical journals so that the researchers do not have to wait for too long for publishing their research work, he added.

comprehensive information on

Prof. Jamshed Akhtar Editor Journal of Surgery discussed issues with PrePrint publications. While some journals, he stated, do not entertain manuscripts published in PrePrint, universities encourage PrePrint publications. It is just like Blog which does not ensure authentic results. Education, he said, is reshaping, some prefer preprint with minimum peer review. At times authorship get changed in every PrePrint. BMJ, PLOS and many universities, he disclosed, encourage PrePrint publication.

Prof. Akhtar Sherin Chief Editor Khyber Medical University Journal published from Kohat highlighted the importance of Scientometrics and questioned does it really reflect the quality of scholarly literature and academic journals. He discussed in detail different Scientometrics, how they are calculated and what is

Medical Association (JPMA) made a presentation on Falling standard of Publication Ethics in Pakistan which she described was a major concern. She highlighted the menace of gift and ghost authorship, sale and purchase of authorship which was spreading fast among the faculty members. She also referred to the growth of predatory journals in Pakistan and desired that authorities particularly regulatory bodies must take some action.

Mr. Shaukat Ali Jawaid described in detail the criteria used for evaluation and recognition of medical journals by the PM&DC. Some of the important issues which are looked into include their importance and relevant. **PAME Session-II**
